



Kob Nyiaj Pab Cov Lagluam Me Kom Rov Khiav Tau

Muaj ntau lub lagluam me nyob hauv Hennepin County tau tiv kev ncu nyiaj thiab tiv kev khiav tsis tau lagluam vim cov tsoomfww caum ntes cov neeg kng teb raws chaw.

Hennepin County Housing and Redevelopment Authority yuav muab nyiaj pab txog li \$2 lab (million) nyiaj los ua nyiaj pab dawb nruab nrab ntawm li \$3000 txog \$10,000 rau cov lagluam me rau lub sijhawm uas tiv kev ncu nyiaj, pab lawv kom lub lagluam khiav tau nyob rau hauv lawv lub zejzog thiab cheem kom txhov muaj kev phem hauv Hennepin County. Cov nyiaj muab los txaus them lub hli nqe tsev xauj lossis nqe tsev yuav.

Hennepin County tabtom koomtes nrog NextStage, uas yog ib lub tuam txhab cev lus pab thiab txais nyiaj rau cov lagluam me hauv zejzog, los ua lub tuam txhab muab cov nyiaj pab dawb tawm.

Cov ntaub ntawv no muajfeem hloov thaum twg los tau, tsis qhia tawm rau leejtwg.

Leejtwg thiaj li muajfeem tau?

Yuav kom muaj feem tau, lub lagluam yuav tsum yog:

- Lub lagluam nyob hauv zos thiab ua kom tau nyiaj, lub chaw nyob tsim muaj nyob rau hauv Hennepin County.
- Yuav tsum muaj peevxwm muab tau ntawv pov thawj qhia tias koj poob nyiaj xiam txog li 30% lossis tshaj rau lub sijhawm tsoomfww caum ntes cov neeg khiav raws teb raws chaw (Operation Metro Surge) rau thaum lub 12 Hli tim 1, 2025 txog lub 2 Hli tim 28, 2026, piv rau lub sijhawm li txhua zaus.
- Toj ntaub ntawv txhua xyoo thiab ntaub ntawv tseem zoo nrog Minnesota Secretary of State.

- Tseem muaj laixee khiav lagluam (yog koj yam lagluam yuav kom koj muaj), laixee tseem zoo, thiab cov se vajtse them raws sijhawm lossis tsis tshuav nqe qhovtwg (dua li ntawm qhov nqe tsev xauj lossis nqe tsev yuav).
- Yog yam lagluam uas muag khoom thiab/lossis siv dag zog ua dejnum rau laj mej pejxeem uas muaj qhov sau nqe rau txhua zaus nyob rau ib qhov chaw. Ua lagluam *Online xwb thiab khiav lag luam hauv tsev tsis muajfeem tau*.
- Yog ib tug tswv uas muaj tsawg tshaj 50 tus neeg ua haujlwm tag hnuv (fulltime) txij thaum lub 12 Hli tim 31, 2025. Cov nyiaj pab dawb muab rau cov lagluam uas tsis muaj neeg ua haujlwm rau lawv tau tsis tshaj \$3000.
- Pib khiav lagluam kom tau nyiaj peb lub hli ua ntej lub 12 Hli tim 1, 2025, kom tau nyiaj txog li \$25,000 thiab tsis pub tshaj \$4 lab (million).

Yuav thov li cas

Cov lagluam ua cov ntawv thov tsis pub dhau **4 teev tsaus ntuj rau 3 Hli tim 25, 2026**.

NextStage, ua yog muaj ntaub ntawv ua haujlwm muab cov nyij pab dawb no tawm, mam li tivtas cov neeg ua ntawv thov mam li qhia seb lawv dim ntawv thov raug xaiv thiab pi bua cov ntaub ntawv.

Thaum hnov tias koj daim ntawv thov tau raug xaiv koj los saib lawm, tus neeg ua daim ntawv thov muaj 5 hnuv los muab cov ntaub ntawv xa tuaj. Cov ntaub ntawv yuav tsum xaj tuaj yog:

- Daim ntawv xauj tsev lossis daim pib them nqe tsev uas qhia tau tias tus tswv lagluam yeej yog nyob rau hauv Hennepin County thiab them nqe tsev txhua hli.
- Ua daim W-9 tiav tag lawm.
- Daim Ntawv Them Se rau lub lagluam (Tax Return) lossis cov ntaub ntawv them se raws lub lagluam.
- Muaj ntaub ntawv ua povthawj tias koj tau poob nyiaj tiag rau lub sijhawm tsoom fww caum neeg ntes.
- Muaj ntaub ntawv ua povthawj qhia txog muaj pestawg tus neeg ua haujlwm rau koj txij li thaum lub 12 Hli tim 31, 2025.
- Lwm yam ntaub ntawv uas tus neeg (administrator) saib cov ntaub ntawv thov nyiaj pab dawb pom tias yuav tsum tau.

Yog koj muab tsis tau cov ntaub ntawv tuaj li qhov peb kom muab tuaj, ces koj yuav raug nrho npe tsis tau qhov nyiaj pab dawb.
