Muaj ntau lub lagluam me hauv Hennepin County, xam muaj cov uas yog cov neej nkag tebchaws cov lagluam thiab cov uas tuav peb cov kab li kevcai uas muaj nqe tshaj, tau tiv kev ncuu nyiaj thiab qheb tsis tau lub lagluam vim tsis ntev no tsoomfww tau caum ntes cov neeg nkag tebchaws. Hennepin County Housing and Redevelopment Authority (HCHRA), muaj txog li \$2 lab (million) ua nyiaj pab dawb muab rau cov lagluam me txog nruab nrab li ntawm \$3000 thiab \$10,000 los pab cov lagluam kom dhau lub sijhawm tiv cov kev ncuu nyiaj no kom lawv nyob thiab qheb tau rau hauv lawv lub zejzog thiab kom cheem tau kev ua phem thoob Hennepin County.

Yuav kom muajfeem tau, cov lagluam yuav tsum yog lub lagluam chaw nyob rau hauv Hennepin County thiab tau tiv kev poob nyiaj ntau tsawv thiab lagluam qheb tsis tau vim qhov (“Operation Metro Surge,”) uas yog tsoomfww caum ntes cov neeg nkag tebchaws uas pib thaum lub 12 hli tim 1, 2025. Cov lagluam yuav tsum ua daim ntawv thov kom tiav thiab yuav tsum nyob tagnrho rau cov nqe ua muajfeem raws li qhia rau hauv qhov Recovery Fund Guidelines.

Cov lagluam me ua muajfeem yuav txais ib qho nyaij pab dawb txog li \$10,000 los pab them li 2 hli nyiaj nqe tsev xauj lossis nqe yuav tsev kom txo tau mentsi rau lub sijhawm lawv poob neeg rau lub lagluam, kaw tau ib ntu, cov neej ua haujlwm pab tuaj tsis tau, thiab lw, yam kev cuam tshuam rau lub sijhawm muaj tsoomfww caum cov neeg nkag tebchaws (Operation Metro Surge).

Lub koomhaum HCHRA tabtom muaj kev koomtes nrog NextStage, uas yog ib lub tuam txhab, txais nyiaj rau zejzrog cov lagluam me thiab pab ntuas qhia, los ua lub tuam txhab muab cov nyiaj no tawm.

Hennepin County ceev txojcai los kho cov lus qhia no thaum twg los tau yuav tsis qhia tawm.

Kev siv cov nyiaj pab dawb

Koj siv cov nyiaj pab dawb coj ua ib zaug them ob lub hli nqe tsev xauj rau koj lub lagluam lossis nqe yuav koj lub lagluam kom pab dhau tej kev ncu ntawm cov nyiaj ntxiag tau kev cuam tshuam los ntawm qhov tsoomfwb caum ntes neeg nkag tebchaws (Operation Metro Surge). Lub koomhaum HCHRA ceev txojcai los xam lwm txojkev los siv cov nyiaj uas ua ib zaug muab no. Txhua yam kev siv yuav tsum yog siv ncaj nraim rau cov lagluam ua muaj chaw nyob nyob rau hauv Hennepin County xwb.

Cov lagluam uas muajfeem

Yuav kom muajfeem, lub lagluam yuav tsum yog

- Cov lagluam ua muaj ob peb qho chaw nyob yuav tau ua ib daim ntawv thov rau ib qho chaw. Tabsi, ib tug tswv lagluam lossis ib tug tswv tshwjxeeb li lub koomhaum yog tus tswv, tsuas txais tau tagrho txog tsis pub tshaj \$24,999 rau hauv Hennepin County Small Business Recovery Funds.

- Lagluam tseem qheb thiab ntaub ntawv tseem zoo rau hauv Minnesota Secretary of State.

Ib daim ntawv thov rau ib lub lagluam ib qho chaw xwb. Yog cov ntawv thov tuaj ntau tshaj li cov nyiaj pab muaj, tus tswv faib nyiaj yuav muab cov nyiaj faib rau cov xub xa cov ntawv thov tuaj txog (daim ntawv tiav yog daim ua muab tau txhua yam ntaub ntawv raws lub qhov program kom muab thiab tau kev pom zoo tau kob nyiaj).

NextStage, uas muaj ntawv cog uas dej num rau HCHRA, mam li tiv tas cov neeg ua ntawv thov yog/thaum twg lawv daim ntawv thov tau raug txais muab koj los saib thiab ua cov ntaub ntawv. **Thaum txais tau daim ntawv qhia tias daim ntawv thov tau muaj koj los saib lawm, cov ua ntawv thov yuav tsum muab cov ntaub ntawv nram qab no xa tuaj tsis pub dhau 5 hnuv ua haujlwm:**

Cov ntaub ntawv xav kom koj muaj tuaj yog cov ntawv qhia txog cov tshev luam them rau koj cov neeg ua haujlwm los ntawm lwm lub chaw luam tsev es tsis yog koj sau, Tus neeg ua ntawv thov daim Federal Form 941/Employer's Quarterly Federal Tax Return, lossis lwm lub Xeev (State) lossis Tsoomfwv kev them nyiaj (Federal payroll)-txheeb rau kev ua se.

Cov ntaub ntawv txog kuv lub lagluam thiab cov ntaub ntawv kuv muab tuaj puas yuav raug suav hais tias yog ntaub ntawv rau pejxeem?

NextStage yuav saw thiab tuav tagrho cov ntaub ntawv thiab cov ntaub ntawv uas peb tau thov kom cov neeg ua ntawv thov muab tuaj. HCHRA yuav tsis nug kom pom nej ntiag tus cov ntaub ntawv dhau tshaj li qhov nej tau qhia tuaj rau hauv daim ntawv thov thiab txhua daim ntawv cog lus rau qhov nyiaj pab dawb ntawv tom qab ntawv. Li cas los, txhua yam ntaub ntawv koj tau muab rau NextStage, uas muaj ntawv koom ua haujlwm nrog HCHRA, poob rau Minnesota Government Data Practices Act thiab muaj qee yam ntaub ntawv yuav suav tias yog ntaub ntawv rau pejxeem “public” nyob rau hauv qhov Act.

Nxiv no, thiab raws li lawv qhov kev txiav txim siab, HCHRA thiab/lossis Hennepin County kuj yuav tso rau pejxeem paub tias cov lagluam uas tau nyiaj pab dawb yog lub twg (xws li lagluam npe, chaw nyob, thiab tau pestsawg), los ntawv kev tso qhia lagluam npe thiab tau pestsawg rau hauv Hennepin County qhov website, los ntawm kev qhia cov lagluam npe, chaw nyob thiab cov nyiaj tau ntawv nrog cov neeg xaiivtsa, lossis lwm txojkev haus kev uas xws li yuav txhawb tau kev tseeb.

Cov nyiaj pab dawb rau cov lagluam ua muajfeem tau txaus o blub hli nqe tsev xauj (lossis them nqe yuav) nyob hauv Hennepin County qhov chaw nyob rau hauv daim ntawv thov, txog li \$10,000. Nyob rau tej lub sijhawm tshwjxwm, HCHRA yuav ceev tuav txojcai los muaj kev pom zoo rau kob nyiaj pab dawb ntawd them lwm yam nuj nqe tabsi yuav tsum kev pom zoo rau yam nuj nqe ntawd..

Nyob rau hauv qhov program cov cai rau cov lagluam uas muajfeem, nqe hais tias “muag khoom ncaj nraim thiab/lossis muab kev pabcuam rau pejxeem raws qhov muaj kev sib pauv” txhais li cas?

Qhov program lub siab xav yog pab cov lagluam uas yog muag khoom ncaj nraim rau cov pejxeem uas tuaj yuav lossis tuaj zaus tos kev pab ntawm qho chaw qhia rau hauv daim ntawv thov, thiab lawv cov nyiaj tau los tau tsawg tshaj li qub lawm vim tau kaw lub lagluam ib nyuag ntu ntawd, lossis neeg tsis tshuam tuaj rau lub sijhawm tsoomfwv caum neeg ntes ntawd uas pab lub lagluam khiav tau rau qhov chaw ntawd. Qhov kev sib pauv (Transaction) yog hais txog muab nyiaj los them yuav ib yam khoom thiab them nqe rau qhov kev pab rau thaum tau txais

kev qhov kev pab lawm. Cov lagluam uas khwv tau nyiaj los yog los ntawm kev muag khoom rau lwm lub lagluam, feem tau yog pab dag zog rau lwm qhov chaw, lossis khwv tau nyiaj los ntawm muaj ntawv toj dejnum txhua hli lossis them nqe tswv cuab txhua hli tsis muajfeem tau kob nyiaj pab dawb hauv qhov program no.

Yuav muab cov nyiaj li cas tuaj yog tias kuv lub lagluam tau xaiv raug/tau kev pom zoo, thiab yuav siv tau li cas?

Cov nyiaj los ntawm qhov program no yog muab los them nqe tsev xauj/nqe tsev yuav lub lagluam rau tus neeg ua ntawv thov, ntshe ho muaj lwm yam uas twb tau kev pom zoo them. Cov nyiaj yuav muaj ib lossis ob txoj haus kev muab tawm:

1. Them ncaj nraim rau tus tswj xauj rau tus neeg ua ntawv thov. Tus neeg ua ntawv thov yuav tsum muab ib daim ntawv rau tus tswv xauj fia kom tiav qhia tau qho nqe tsev them txhua hli, lees paub txog cov nyiaj pab dawb ua them rau tus neeg ua ntawv thov thiab muab tus tswv cov ntaub ntawv txog lub tuam txhab kom txais tau nyiaj ncaj nraim rau tom nws lub tuam txhab.
2. Yog xav kom tau qhov nqe tsev xauj ua tus neeg ua ntawv thov twb them lawm uas nyob rau lub sijhawm qhov program tau hais txog. Tus ua daim ntawv thov yuav tsum muaj cov ntaub ntawv qhia tias nws twb yeej them qhov nqe tsev ua ntej lawm mas peb mam li xa cov nyiaj pab dawb ntawd tuaj. Cov nyiaj ua them rau cov yuav lub tsev/qhov nqe tsev tsuas yog muaj xa tuaj raws qhov koj them xwb.

yog nws tseem muab tau tagnrho cov ntaub ntawv povthawj, xws li ntaub ntawv qhia tau kev poob nyiaj txog li 30% lossis siab tshaj vim qhov Operation Metro Surge.

Ib cov ntaub ntawv piv txwv uas pom tau tias tsim nyog yog cov Ntawv Qhia Se Saw los rau neeg yuav piv rau tib lub sijhawm xyoo tag los, Ntawv muab los ntawm lwm lub laglum uas qhia rau koj txog cov nyiaj koj tau los ntawm kev muag khoom, Cov ntawm los ntawm lub chaw luam credit card, Cov tws muag khoom lossis cov ntawv qhia los ntawm lub tshuab ntau nqe (register).

Tabsi, Hennepin County cov nyiaj yuav tsis pub los siv them tib qho nqe uas lwm lub twb muab tuaj lawm (txhais tau tias “tsis pub rau noj ob zaus”). Lub lagluam yuav tsum muaj ntawv povthawj qhia tau tias kob nyiaj tau los lwm qhov los yog them lwm yam nqe es tsis yog them nqe tsev xauj rau koj lub lagluam lossis them tus nqe yuav koj lub lagluam raws li cov lus teem tseg los ntawm qhov Recovery Fund cov lus qhia cai .

Peb yeej totaub tias muaj ntau lub lagluam tau txo lawv cov sijhawm ua luam lossis kaws tau ib nyuag ntu nruab nrab thaum lub 12 Hli 2025 thiab lub 2 Hli 2026 vim qhov Operation Metro Surge. Qhov kaws tau ib ntu ntawv tsis ua rau koj lub lagluam tsis muajfeem thov. Cov lagluam uas kaws kiag lawm tsis ua lawm no ces yuav tsis muajfeem thov kob nyiaj pab dawb no.
